 - a. Rebecca Jordan (guest) attended meeting as she was invited by Michael Molesky as a potential commission member. Rebecca informed the group that she has a brother who currently is a recipient of personal care services. Rebecca's brother currently lives out of state, but at some point, will likely need to move to CA with her. Rebecca expressed interested in applying to be appointed to the IHSS Advisory Commission under the category of at large representative of a relative of personal care services.
 - b. Taylor reported that she met with Community Life Services and suggested they be invited to a future commission meeting.
 - c. Sones reported that effective September 30th Elderday will be transitioning from temporary alternative services to regular congregate services. To keep everyone safe, Elderday is testing their staff twice a week and their participants once a week.
 - d. Antonio Rivas (guest) shared that Advocacy Inc. is no longer being funded by the county. The program helps those senior citizens who have problems within their home. Antonio came to the commission meeting to request that the IHSS Advisory Commission help advocate for the restoration of their funding.
 - Sones informed the group that the services provided by Advocacy Inc are primarily for adults who are not eligible for In-Home Support Services

- 1. Taylor suggested that the regional center be invited to speak about their home care program.
- Staff reported that there are potentially two guest speakers on the October agenda: the Volunteer Center and a representative from the CAO's office.

b. IHSS Provider Trainings

- i. Sones informed the commission that the meeting packet included the IHSS Provider Training Flyer from the Health Project Center.
- ii. Staff mentioned that earlier this year, the commission selected six training topics for our IHSS care providers. The Health Project Center graciously offered four more provider training courses, at no additional cost to the county, making it a total of ten courses available to IHSS providers.

c. Annual Report Review

- i. The commission reviewed the 2022 IHSS Advisory Commission biennial report.
- ii. Sones highlighted the goals that the commission has been working on and identified others that have not been addressed.
 - One goal noted on the report was to monitor the ongoing use of the Electronic Visit Verification (EVV) – Sones suggested the commission receive an update on this as this item has been discussed on several occasions and it would be good to receive an update on how EVV is going in our county.

d. Provider Concerns

- i. Sones reminded the commission that this is a standing item for our provider representatives to bring up any concerns they may have.
- ii. There were not concerns report.

e. IHSS Program Updates

- i. Staff provided the following IHSS Program Updates:
 - 1. The county is re-releasing the Request for Proposal (RFP) for the countywide needs assessment for the Master Plan for Aging
 - 2. The Human Services Department (HSD) will be receiving digital divide money from California Department for Aging. HSD plans to go to the Board of Supervisors to accept the funds in October and to ask to release a RFP to partner with a Community Based Organization on this project. The goal is to be able to provide technical support in people's homes. The commission was asked to provide suggested potential partners for this project.
 - We are expanding Adult Protective Services (APS)
 staffing/capacity due to new funds from this past budget year
 budget initiative that allocated more money to APS.
 - 4. The Public Guardian transition from Health Services Agency is complete – Public Guardian is now in Human Services Department to help build a stronger elder justice system and align programs

that support vulnerable adults under one division, which is consistent with statewide best practices and Master Plan for Aging initiatives

5. We have completed two Public Service Announcements on elder abuse/neglect— One on Financial Abuse and the other on Self-Neglect – please go to santacruzhumanservices.org to see them – we hope to air them on local stations.

f. Public Authority Updates

i. Staff provided an update on the Back-Up Provider System that was reported at last month's meeting. Public Authority staff have been working diligently to implement this system by the October 1st deadline. Our clerical support staff completed a mailer to recruit providers who are currently active on the registry. The mailer was phase one of the recruitment. Phase two will be direct calls to our registry providers – this is expected to begin next week.

g. Subcommittee Reports

 - 1. Anderson reported that he was able to find the provider enrollment link on the website.
- iii. CICA Conference Calls (Campbell)

 - a. This month's speaker was Donna Calame, a retired Public Authority Director in San Francisco. Donna discussed the history of IHSS taken from Hale Zukas. The program started in1953 when polio was the big focus, and it was funded by the March of Dimes. When it's funding diminished, the people came to the state for funding, and they got a maximum of \$300 a month for a caregiver, attendance server as they were called back then. Then in 1973, they added any fully disabled persons, not only those with or who had polio.

2. Motion to Approve April 19, 2022 Meeting Minutes

3. Public Comment: None

4. New Business/Action Items:

4.1. Live Oak Senior Center Eviction Update

Sehorn reported that Senior Network Services and Meals on Wheels were given six months to move out of their Live Oak facility as of May 2022 so the Live Oak School District could build teacher housing at that location. The County volunteered to partner with the school district to achieve resolution and Supervisor Koenig met frequently with key stakeholders. Senior Network Services will present a proposal to take over liability for building repairs at the next Live Oak School District meeting on June 29, 2022. Commissioners are encouraged to attend.

Brennan arrived.

4.2. Long Term Care Ombudsman Program

Matzie provided an overview of the role of the Long-Term Care Ombudsman Program (Advocacy, Inc.) which received no CORE funding this year, substantially limiting their ability to serve some of the County's most vulnerable residents. The program is extremely effective with a resolution rate of about 65%. Commission discussed potential opportunities for advocacy and support.

4.3. County Social Services Overview

Morales provided an overview of changes to the County's Human Services Department - Adult and Long-Term Care (ALTC) Division providing a continuum of safety net services for older adults and persons with disabilities including the IHSS program, Adult Protective Services (APS), TLC (Transforming Lives Through Care) case management program, Veterans Services office, and recently, the Public Guardian Team.

A Governance Board was established to implement the Master Plan for Aging in the areas of housing, healthcare, inclusion/equity, non-isolation, work, protection, caregiving, and income security. A County-wide needs assessment will be conducted to determine gaps and priorities.

The State is developing a guaranteed income pilot program and additional funding has been allocated for expansion of several programs (APS, full-scope Medi-Cal for seniors 50+ regardless of immigration status, and Cal-Fresh for seniors 55+ regardless of immigration status), as well as a reduction in share-of-cost for seniors and people with disabilities and a permanent backup provider system for the IHSS program.

Emerging issues: the two most critical issues are the increase in homelessness for seniors and the caregiving workforce shortage. Commission discussed potentially participating on the Master Plan for Aging Governance Board subcommittees as appropriate and invited Morales to return with any opportunities to support the ALTC Division's efforts.

Childers and Brennan left meeting

- 4.4. Consider Advocacy Opportunities Related to Recruiting and Retaining IHSS Caregivers Commission discussed opportunities to support IHSS Caregiver recruitment and retention. Morales recommended that the Commission pend their advocacy until clear opportunities to address these complex issues become available at the State and Federal level.
- 4.5. Assembly Bill 361 Statement of Findings

Commission considered whether to authorize meeting remotely under the provisions of AB 361 at the next meeting.

SANTA CRUZ COUNTY IHSS ADVISORY COMMISSION'S FINDINGS PURSUANT TO ASSEMBLY BILL 361 AUTHORIZING TELECONFERENCE MEETINGS AS A RESULT OF THE CONTINUING COVID-19 PANDEMIC STATE OF EMERGENCY AND HEALTH OFFICER RECOMMENDATION FOR SOCIAL DISTANCING

WHEREAS, this IHSS Advisory Commission is a legislative body under the Brown Act as defined under Cal. Gov. Code section 54952(b) and Santa Cruz County Code Section 2.38.110; and

WHEREAS, on September 16, 2021, Governor Newsom signed Assembly Bill 361 ("AB 361"), urgency legislation effective immediately, that amended Government Code section 54953 to permit legislative bodies subject to the Brown Act to continue to meet under modified teleconferencing rules provided that they comply with specific requirements set forth in the statute; and,

WHEREAS, pursuant to AB 361 and Cal. Gov. Code section 54953(e)(1)(A), a legislative body may meet under the modified teleconferencing rules during a proclaimed state of emergency, and where local officials have imposed or recommended measures to promote social distancing; and

WHEREAS, on March 4, 2020, Governor Newsom issued a Proclamation of State of Emergency in response to the COVID-19 pandemic, and which remains in effect; and

WHEREAS, on September 30, 2021, Santa Cruz County Public Health Officer Dr. Gail Newel strongly recommended that legislative bodies in Santa Cruz County continue to engage in physical/social distancing by meeting via teleconference as allowed by AB 361 and confirmed that she will regularly review and reconsider this recommendation and notify the public when it is no longer recommended; and

WHEREAS, pursuant to AB 361 and Cal. Gov. Code section 54953(e)(3), within 30 days of the date the legislative body first holding a teleconferenced meeting under the modified rules, and every 30 days thereafter, a legislative body can continue to hold such teleconference meetings provided it has reconsidered the circumstances of the state of emergency and determined either that the state of emergency continues to directly impact the ability of the members to meet safely in person or that local officials continue to recommend measures to promote social distancing; and

WHEREAS, on October 22, 2021, the IHSS Advisory Commission held its initial teleconference meeting under AB 361; and

WHEREAS, on January 27, 2023, the IHSS Advisory Commission held a subsequent teleconference meeting under AB 361; and

WHEREAS, the IHSS Advisory Commission has reconsidered the circumstances of the current state of emergency and finds that the COVID-19 pandemic continues to directly impact the ability of members of the public to participate safely in person and further finds that the Santa Cruz County Public Health Officer continues to recommend measures to promote social distancing; and

WHEREAS, in the interest of public health and safety, and due to the emergency caused by the spread of COVID-19, the IHSS Advisory Commission deems it necessary to utilize the modified teleconferencing rules set forth in AB 361;

NOW, THEREFORE, the IHSS Advisory Commission makes the following findings by a majority vote:

Section 1. The foregoing recitals are true and correct, and adopted as findings of the IHSS Advisory Commission.

Section 2. Effective immediately, and for the next 30 days, the IHSS Advisory Commission will meet via teleconference as authorized under AB 361 and Government Code section 54953(e)(3).

Section 3. No later than thirty (30) days from making today's findings, or at the next scheduled meeting, the Commission will reconsider the circumstances of the COVID-19 state of emergency and, if necessary, adopt subsequent findings to continue holding teleconference meetings in accordance with Government Code section 54953(e)(3).
