 - a. Welcome new commissioner Charlie Walker II Provider Representative
 - Commissioner Walker introduced himself, currently a live-in provider, region 3 SEIU 2015 Vice President.

 - a. Alicia Morales Division Director for the Adult and Long-Term Care Division informed that she was here to answer any questions the group may have. Also informed that the department is waiting to see what will happen at the federal/state level. Governor stated that if Medicaid is cut, the state will backfill hoping this will be true. Staff are worried about what is going on, worried about clients. A time of uncertainty Santa Cruz County is committed to its values. Working on instruction to staff in the event Immigration and Customs Enforcement were to come in and how to deal with it. Potential cuts to community living...but nothing official. There is a new MOU for IHSS providers, \$20.50/hour as of March 2025.

- 6. Guest Speaker: Janie Whiteford, California IHSS Consumer Alliance (CICA)
 - a. Janie, president of CICA and Chair of the Santa Clara County IHSS Advisory Board, presented the following information:
 - Mandate of commission is to provide recommendations to any entity involved with IHSS – BOS, PA, IHSS, State, Federal, Medi-Cal (IHSS is a MC program).
 - ii. CICA, a 501c, was initially established to assist county advisory boards, but have evolved since then.
 - iii. Janie sits on a lot of commission and committees at the state level DACLAC (formerly Olmstead committee), CARA (CA Alliance of Retired Americans), 2 MPA committees.
 - iv. IHSS is a large program, state pays a lot of money to the program, more than any other social service program.
 - V. CICA executive board, president, vice president, treasurer, secretary from various counties + 20 executive vice presidents from various counties + members at large (individuals who want to be part of CICA).
 - vi. 26 counties are members of CICA; Santa Cruz is not would like to see us join. Membership fee is \$750; membership includes:
 - 2 x month meetings trainings or informational sessions on topics such as: development of advisory boards, recruitment, outreach are a few of the items they touch on, legislation – Brown Act bills to allow advisory bodies to hold meetings via zoom (non-decisionmaking bodies), statewide collective bargaining bills – the most

recent report had no consumer voice included, CICA will be writing a rebuttal letter to it. They are currently working on a training program for consumers – developing to assist consumers in their employer role.
