- i. Staff reported that as part of the recent changes to section 2.38 of county code, all commissions are to approve their meeting schedule each year in the month of April. A copy of the May 2024 April 2025 meeting schedule was included in the meeting packet. Staff reminded the commission that for now, the meeting location for the IHSS Advisory Commission was set to 1400 Emeline Ave, but per the commission's vote in February, the commission will revisit the location of its meetings at the June 2024 commission meeting.

7. Guest Speakers:

- a. Alicia Morales, Division Director, Adult and Long-Term Care
 - i. Morales provided a brief intro about herself: has been working in the Aging field for almost 30 years: Adult Protective Services in Los Angeles County, Alameda County, and has been with Santa Cruz County for the past 4 years. She has served on the Executive Board for Public Guardians for 7yrs and was president at one time. This is our time, by exec order on MPA/council member integrate elder justice system, make structural changes. Elder justice, APS, LTC, PGO, SNS including disabilities. Morales provided info on the following topics:
 - 1. Provider recruitment Morales indicated that this is a challenge in every county. On average, statewide 70% of providers are family members; in Santa Cruz County, only 56% of providers are family members. This makes provider recruitment much harder. The registry has seen increase in new providers of 20%. This was due to internal changes, more employees, and strengthening the Public Authority. Anna Cerna was recently hired as the new Public Authority Social Work Supervisor which will including provider recruitment. At the State level, there was legislation introduced last year to allow undocumented family members to be eligible to be providers. This bill has been reintroduced this year. Non-family members would be the next step.
 - 2. Contract mode, Morales indicated that only San Francisco County has this mode, and it may not happen locally due to its high cost. There is an ask for funding from the state and we are working with managed care (Alliance and Kaiser) to establish relationships with local Managed Care Plans via Memorandums of Understandings with IHSS, among others. There is a strong focus on referrals for Enhanced Care Management services through Senior Network Services, Community Bridges and other community-based

- organizations. At the regional level, the Bay Area Social Services Consortium is offering a stipend for Master of Social Work training focusing on older adults, like the title 4E Waiver for Family and Children Services.
- Master Plan for Aging, concerned with funding. No planned cuts to adult services, but no additional funding. The Master Plan for Aging supports policies that promote healthy aging. In Santa Cruz County, 1 in 3 residents will be over age 65 by 2030. The Older American's act is being reviewed.
 - A. Auld (public) mentioned that she can't get a provider. There is no quality control, consumers are the QA as an employer. Do you audit IHSS program. Is it successful?
 - i. Morales responded that the IHSS program came from disability movement in Berkley. Care from the community will care for the community. 90% of providers are known by the individual. Public Authority is a back-up plan, they recruit providers and maintains the registry.
- b. Elizabeth Byrd, Sr. Human Services Analyst, Adult and Long-Term Care
 - i. Elizabeth Byrd reported that Santa Cruz County is working on the Master Plan for Aging. In June 2023, the Board of Supervisors and the American Association of Retired Persons recognized Santa Cruz County as age friendly. An age friendly community is one where its residents can age in place, break down isolation, and allow for aging in an empowered way. A governance group was formed which comprised of elected officials. A county Needs Assessment survey was initiated by ALTC. The goal was to have 1K respondents; we received 2500 online survey responses alone. We recognize that not all pops were represented, so we are looking at how to address the needs of those who didn't answer. Data is a starting point, who's missing? Working with Clarity, who uses focus groups to inform next steps. Includes other data sets, surveys, etc. Dientes, CSOA, US Census.

4.5. Consider 2022-2023 Biennial Report

Commission reviewed the 2022-2023 Biennial Report and amended to add affiliations and revised goals to include language related to CORE funding, Solutions Summit, State DEI efforts, and Enhanced Care Management.

Motion to approve the 2022-2023 Biennial Report as amended.

Motion/second: Taylor/Doty

Motion passed unanimously.

4.6. Consider Advocating for the Seniors Commission as a Distinct Advisory Body

Commission discussed recent Board of Supervisors' direction to the *A Santa Cruz County Like Me* (ASCCLM) task force to return in January with recommendations on streamlining the County's advisory body system to bring current and increase efficiency. The Commission does not yet know whether they will be included in recommendations but expressed concern that they may not be given an opportunity to advocate for their continued existence before recommendations are published.

Motion authorizing Commission Chairs to draft and submit a letter to the Board of Supervisors advocating for their continued existence as a distinct advisory body.

Motion/Second: McKibbin/Taylor **Motion passed unanimously.**

4.7. Senior Center Assessment/Survey Report

McKibbin summarized findings from her research into programs and services provided by the six senior centers in Santa Cruz County. Four centers either have support from their cities (Santa Cruz, Scotts Valley, Watsonville) or are funded by their members (Capitola), but the Highlands Center which had previously relied upon support from CORE funding, are struggling financially. Former Live Oak Senior Center was closed voluntarily, unrelated to any financial concerns. The findings reinforced the importance of senior center services. Potential projects included a virtual forum/town hall for center directors, fostering connection between centers, promoting center utilization, developing funding recommendations, and promoting educational opportunities for senior center directors. Johannessen will research whether the Solutions Summit includes a breakout specific to senior center directors.

Motion to Establish an Ad Hoc Senior Center Advocacy Subcommittee to develop a recommendation of the purpose and scope of the special project for consideration by the Commission.

Motion/Second: Taylor/Doty **Motion passed unanimously.**

Childers appointed Doty, McKibbin, Taylor, and Childers to the subcommittee.
