- 5. Oral Communications and Announcements:
  - a. Kiebert-Boss reported that there will be a Harvest Festival at Monterey Bay Horsemanship and Therapeutic Center on September 23<sup>rd</sup>.
  - b. Kiebert-Boss reported that there will be a Day of the Dead Celebration in Pajaro Valley on October 5<sup>th</sup>.
  - c. Sones reported that the Certificate of Occupancy was granted for Elderday.
  - d. Taylor will put together a calendar of Farmer's Markets and Library Storytelling for distribution to committee members.
  - e. Molesky requested a calendar of other committee meetings.
- 6. Presentation: Representational Government Rita Sanchez
  - a. Ms. Sanchez presented on "A Santa Cruz Like Me", a partnership between Santa Cruz Ventures and Santa Cruz County to "paint a picture of Santa Cruz County's representative bodies". Ventures used data from a survey given to Santa Cruz, Boards, Commissions and Supervisors, to reveal how well the county reflects the diversity of our region. Some of the key findings included:
    - i. Critical underrepresentation of South County on county boards and commissions.
    - ii. Critical underrepresentation of renters.
    - iii. Critical underrepresentation based on race, ability, and age.
    - iv. Critical overrepresentation of college graduates.
  - b. The committee offered several suggestions to attract new committee members, such as offering stipends, childcare, increased accessibility (virtual participation), and better communication to attract diverse members.
  - c. A hard copy of the presentation was given to committee members present.
- 7. Regular Agenda Action Items
  - a. Consumer/Provider Survey
    - i. The decision was made to hold off on the survey pending input from the Master Plan on Aging (MPA).
  - b. Summit Planning
    - i. Staff gave brief background on previous summits, which have paused due to COVID.
    - ii. There was a suggestion that small grants from the Seniors Council or the Alliance on Aging could help for future Summits.
- 8. Regular Agenda Information Items
  - a. Updates/Housekeeping
    - i. Reminders from the Chair
      - 1. Biennial Report Due 01/31/2024
        - A. Staff proposed starting to discuss the report in October, then completing the final report in November.

- 2. Staff provided the following reminders:
  - A. Staff will reach out to members who have not yet completed their Oath of Office, which must be done by September 30<sup>th</sup>. Commission members that have not completed their Oath of Office by September 30<sup>th</sup> will not be able to vote or count towards a quorum in meetings beginning October 2023. There is a separate oath for each commission.
  - B. The Clerk of the Board will be sending a survey to all county commissioners. The survey will include the required Brown Act training, which be completed by all appointed commissioners (county wide).
- ii. Topics & Speakers
  - 1. Molesky will look into guest speakers.
- b. IHSS Providers
  - 1. Fohrman mentioned parking concerns at Via Pacifica.
- c. IHSS Program and Public Authority Updates
  - i. The IHSS provider registry currently has 219 care providers, with 37% (81 ppl) of those available for additional work.
  - The Master Plan for Aging Steering committee is continuing to meet. There have been 3 focus groups (caregivers, monolingual Spanish speaking, and older adults with a focus on access and functional needs). Feedback from steering committee was given to marketing firm, who is currently working on branding for our local age friendly and MPA efforts. Anticipate the survey will be ready for release early 2024.
  - Senior's Council was awarded a \$170K planning grant from California Department of Aging with letter of support from HSD. Plans to coordinate solutions summit.
  - iv. November is the Home Caregiver Recognition Proclamation. Consumers are needed to attend the BOS meeting on October 17<sup>th</sup> to present impact statements. Public comments are accepted at 9:00AM after the consent agenda.
  - v. In honor of Home Caregivers in November, gifts will be given away to those in attendance, which include a lunch tote and 2 tumblers with the Public Authority logo. Emails and flyers will be distributed.
- d. Subcommittee Reports
  - i. Staff reported that a recent commission liaison training dealing with Subcommittees. Staff informed that subcommittees would be added to the October meeting agenda so the commission can take action.

## **Types of Subcommittees**

## <u>"Standing" Subcommittees</u>: *irrespective of their composition which have a-*

- Continuing subject matter jurisdiction; or
- Meeting scheduled fixed by charter, ordinance, resolution; or
- Formal action of a legislative body
  In other words: \*Permanent, ongoing,
  or open-ended time period
- → Are "legislative bodies" under the Brown Act!!!

## "AD HOC" Subcommittees: "For This"

- Allowed for Advisory Commissions only (No decision-making duties or powers in their ordinance);
- Accomplishing or resolving a specific task or defined purpose;
- Temporary in nature and for a short period of time;
- Only as necessary and/or needed;
- Should be less than a quorum of the larger Commission or Board

→ Only if meets these requirements, then NOT subject to the Brown Act!

## Santa Cruz County Code Section 2.38.230

## (A)

- Establishment and dissolution of all subcommittees shall be reported in writing to the Board by the Commission or Committee which appointed the subcommittee.
- Members of the subcommittee need not be commission or committee members (except if state or federal statute or ordinance says differently)
- The commission or committee chairperson "designates" a commission or committee member to serve on a subcommittee. (Could also be done via voting or volunteering at a meeting.)

(B)

 Any "subcommittee" established by a commission or committee to assist them <u>for longer than six months</u> must follow Section 2.38.110 through 2.38.150, which includes the Brown Act meeting provisions.

## IHSS Advisory Commission Report - 2024 2022 - 2023

#### **Role of the Commission**

The In-Home Supportive Services (IHSS) Advisory Commission is a state-mandated advisory board established under AB 1682. The powers and duties of the IHSS Advisory Commission, as defined by Santa Cruz County Board of Supervisors' Ordinance #4655, Chapter 2.124.070 of the Santa Cruz County Code, are to:

- 1. Serve in an advisory capacity to the Board of Supervisors, as the governing board of the IHSS Public Authority, and any administrative body in the County related to the delivery and administration of the IHSS;
- 2. Review policies related to the delivery of IHSS and make recommendations to the Board of Supervisors regarding any proposed changes;
- 3. Review pending State and Federal legislation that may impact the IHSS program, consumers, and/or providers and make recommendations to the Board of Supervisors regarding any proposed changes;
- 4. Stay informed and educated on IHSS and Public Authority issues;
- 5. Provide a forum for consumers and providers of personal assistance services, advocates and other interested parties to participate in IHSS policy and program development.

#### Meetings dates, time and location

The IHSS Advisory Commission meets on the fourth Friday of every month from 1:00 - 3:00PM at 1400 Emeline AVE., Santa Cruz, in Room 206. Due to ongoing recommendations from the local health department, , the commission met virtually via teleconference for the majority of its meetings in 2022. The commission does not meet in the months of July and December.

### **Commission Structure**

The Commission comprises no more than 11 members, of which a majority must be current or former users of personal assistance services paid for through public or private funds. The remaining slots include: two current for former providers of In-Home Supportive Services; and three at-large members from any of the following: a representative of an organization that advocates for people with disabilities or seniors and/or a representative who also concurrently holds a seat on either the Santa Cruz County Seniors Commission or the Commission on Disabilities.

Currently, there are two vacancies that the commission is seeking to fill. These vacancies are comprised of one former or current user of personal assistance services and one representative of an organization that advocates for people with disabilities or seniors.

## IHSS Advisory Commission 2020-2021 Report

#### **Commission staff**

The IHSS Advisory Commission is staffed by the Public Authority, under the auspices of the Human Services Department. Staff from the IHSS Program attend each meeting.

#### Attendance 2022 and 2023

#### **Goals and Accomplishments**

During 2022 and 2023, the IHSS Advisory Commission:

- Hosted the following guest speakers: Max Unmey from the County's Master Shelter Plan, Matthew Sundt from the County's Housing Element Update, Jim Lyons and Angela Millhouse from the Central California Alliance for Health, Yesenia Cerna from the County's Human Services Department, Grecia Quintero and Ivette Vazquez from the San Andreas Regional Center and Rita Sanchez from the County Administrative Office.
- 2. Welcomed two new commission members: Rebecca Jordan (relative of consumer) and Christine Kiebert-Boss (consumer).
- 3. Renewed membership with the California IHSS Consumer Alliance (CICA). REMOVE?
- 4. Kept informed of state budget issues by California Association of Public Authorities advocates.
- 5. Received updates of the State Olmstead Advisory Board as relevant.
- 6. Collaborated with the Health Project Center to develop training curriculum for IHSS care providers.
- 7. Monitored the impact of the COVID-19 health pandemic on IHSS recipients and care providers. REMOVE?
- 8. Transitioned from remote meetings to in-person meetings due to the end of the public health emergency.
- 9. Kept informed on the Master Plan on Aging (MPA).
- 10. Successfully implemented disaster protocols due to local fire and flood disasters.
- 11. Continued providing ongoing input to IHSS Public Authority staff for posting relevant and educational information on the IHSS Public Authority website.
- 12. Shared information with Seniors Commission and Commissions on Disabilities.
- 13. Subcommittees monitored activity in the areas of interest to IHSS recipients and providers.
- 14. Performed ongoing work to fill the remaining vacancies in the commission.

### Future Goals – FEEDBACK NEEDED

The goals of the IHSS Advisory Commission include the following:

IHSS Advisory Commission 2020-2021 Report

- 1. Participate in Public Authority Registry recruitment efforts. Particularly providers willing to work in Santa Cruz and San Lorenzo Valley and/or willing and able to provide care for high needs clients.
- 2. Monitor the success of the provider enrollment process.
- 3. Promote ongoing education of IHSS for consumers, care providers and the community.
- 4. Work collaboratively with the Health Project Center to develop training curriculum for IHSS providers.
- 5. Participate in the development of enhanced supports for IHSS recipients and care providers.
- 6. Continue to monitor payroll activity to assure providers are being paid timely.
- 7. Monitor the ongoing use of the Electronic Visit Verification requirement for IHSS and its impact on consumers and providers.
- 8. Increase collaboration with the local labor organization.
- 9. Network with community-based organizations and other commissions to solve issues that affect IHSS and related services.
- 10. Hold IHSS Advisory Commission meetings in south and mid-county locations.
- 11. Work collaboratively with partner agencies and commissions on disaster planning and emergency preparedness.
- 12. Monitor the impact of the CZU fire and its aftermath on consumers and providers and make recommendations as necessary.
- 13. Identify community resources that IHSS consumers and providers can access in emergency situations.
- 14. When allowable under public health recommendations, the commission will seek to resume the Caring Community Summit.
- 15. Resume new commissioner orientation and conduct annual refreshers for existing commissioners.
- 16. Advocate for fall prevention and supports in the home of all recipients of IHSS.

### **Recommendations – FEEDBACK NEEDED**

Recommendations from the IHSS Advisory Commission include the following:

- 1. Advocate for mixed housing with caregivers to support integrated caregiver and community planning.
- 2. Advocate for a living wage for caregivers so they can remain in our community.
- 3. Advocate for the county to develop a comprehensive emergency preparedness program.
- 4. Explore the feasibility of an agency-based (Contract Mode) IHSS system in Santa Cruz County.
- 5. Advocate for the needs of IHSS recipients and caregivers to be included in plans when developing the MPA.

## Santa Cruz County Board of Supervisors Proclamation

PROCLAMING NOVEMBER 2023 AS IN-HOME SUPPORTIVE SERVICES CAREGIVER MONTH IN SANTA CRUZ COUNTY

WHEREAS, over 2,800 In-Home Supportive Services (IHSS) caregivers provide home care services and support in Santa Cruz County, making it possible for over 3,100 low-income disabled and elderly Santa Cruz County residents to remain living independently in their homes; and

WHEREAS, providing services and support for the disabled and elderly to remain living in their homes is a humane, dignified, and compassionate alternative to hospitalization or other potential institutional placements that disabled and elderly adults become susceptible to without viable IHSS care; and

WHEREAS, the County of Santa Cruz's IHSS professionals who provide these physically demanding and emotionally challenging home care services to low-income disabled and elderly Santa Cruz County residents do so with great sensitivity, honesty, patience, trust, commitment, dedication, and compassion; and

WHEREAS, in recognizing the work of IHSS caregivers to promote independence, dignity, and quality-of-life for disabled and elderly adults, numerous national organizations have joined together in declaring the month of November as National Home Care Month to recognize, honor, and support the valuable contributions of home care workers; and

WHEREAS, the County of Santa Cruz through its Human Services Department, its IHSS Public Authority, and its IHSS Advisory Committee are committed to acknowledging the contributions and importance of Santa Cruz County's IHSS caregivers to promote independence, dignity, and quality-of-life for Santa Cruz County's disabled and elderly residents.

NOW, THEREFORE, I, Zach Friend, Chair of the Santa Cruz County Board of Supervisors, hereby proclaim the month of November 2023 to be In-Home Supportive Services Caregiver Month in Santa Cruz County.
